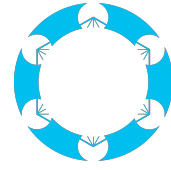


# Terms of Service



## Overview

This website is operated by Cellulim. Throughout the site, the terms “we”, “us” and “our” refer to Cellulim. Cellulim offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our site and/ or purchasing something from us, you engage in our “Service” and agree to be bound by the following terms and conditions (“Terms of Service”, “Terms”), including those additional terms and conditions and policies referenced. These Terms of Service apply to all users of the site, including without limitation users who are browsers, vendors, customers, merchants, and/ or contributors of content.

Please read these Terms of Service carefully before accessing or using our website. By accessing or using any part of the site, you agree to be bound by these Terms of Service. If your order is in stock and we process the charges to your credit card, it will ship within five business days from the date of your order.

We will send you tracking information within 24 hours of your order leaving the warehouse to the e-mail address you provide when checking out.
